

## REALTORS® RELIEF FOUNDATION Application for Wildfire Disaster Relief Assistance

A wildfire disaster relief fund of just over \$25,000 is now available from the REALTOR® community. The purpose is to assist individuals and families in Idaho whose primary residence was destroyed or damaged by a wildfire in 2015.

### Type of Assistance

Grants are available for qualified applicants, whose primary residence (located in the state of Idaho) was damaged or destroyed by a wildfire in 2015, to offset their monthly mortgage expense *or* the cost of temporary shelter due to displacement from said residence. Grants will be limited to one month of assistance, up to \$1,000 per applicant, and one grant per residence. The deadline for submitting this application is ~~December 31, 2015~~ **March 30, 2016 (date extended!)**. This assistance is for **housing relief only**; other expenses such as a vehicle purchase, rental, repair and/or mileage are ineligible for reimbursement under this program.

### Eligibility

Recipient must be a full-time resident of the state of Idaho and a United States citizen (or legally admitted for residence in the United States). Applications will be reviewed without knowledge of the identity of the applicant.

### Confidentiality

All information provided on this form by the applicant will remain confidential and will only be available to those who need to confirm eligibility and to those who process the grant payments. This includes providing a copy of this application to the applicant's lender or landlord, if requested. It will not be shared with other parties for any other purpose.

### Disbursement of Funds

In order to provide for a reasonable and equitable distribution of funds, grants will be provided on a first come, first served basis.

All grants are contingent upon the availability of funds. Grants will be jointly payable to applicant and mortgage lender or landlord.

The REALTORS® Relief Foundation reserves the right to accept or reject any application and, or to cancel any grant for good and sufficient reasons. The Foundation also reserves the right to change the application criteria at any time.
